Prospective candidates and nominators should verify their financial status and any other qualifications required by the rules of the Branch prior to lodging nominations.

Candidate Statements

Candidates may submit a statement to be included with ballot material. Only statements which comply with the Rules and are received by Chris Cox Returning Officer no later than 12:00pm (AEST) 12/9/2018 will be published. Candidate statements are restricted to a maximum of 400 words and sent as a word doc. Passport sized photographs should be sent as a jpeg doc. Voting Period

The ballot, if required, will open on 10/10/2018 and close at 10:00am (AEST) on 07/11/2018.

Scrutineers
