Candidate Statements

Candidates may submit a statement of no more than 400 words and a passport sized photograph to be included with ballot material. Statements should be provided in MS Word format and may be emailed to IEBnominations@aec.gov.au.

Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm Australian Eastern Standard Time (AEST) on 18/09/2025 can be accepted.
